Board directed staff to investigate providing the minimum requirements for public advertising in the event the provided quotes exceed the statutory limit.

Additionally, staff should investigate setting up on-call contracts to address future rapid procurement for emergency and small-scope projects.

Mr. Freeman motioned to amend the Rules and Regulations Resolution 2024-02 Sections 1.1,1.2,1.4,4,6.2,7.5,11.7.3, 10, and 17, noting changes to the PIF amount. Mr. Kampmann seconded. The motion passed unanimously. **Approved** 

Mr. Freeman made a motion to adopt Resolution 2024-03, setting the mill levies. Mr. LaVanchy seconded. The motion passed unanimously. **Approved** 

Mr. Kampmann made a motion approving the Hebert Inclusion. Mr. Freeman seconded. The motion passed unanimously. **Approved** 

Mr. Kampmann made a motion to approve the Idaho Creek Line Extension Agreement. Mr. Freeman seconded. Mr. Cook opposed. The motion passed. **Approved**
